

COMMUNITY CRATES COMPETITION

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED BY LAW. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. INTRODUCTION

These are the official rules (the “Rules”) for the “Community Crates” Contest (the “Contest”). Beatsource’s posted privacy policy (<https://support.beatsource.com/hc/en-us/articles/4413209937684>) and terms and conditions (<https://support.beatsource.com/hc/en-us/articles/4413195884692>) are incorporated herein.

2. CONTEST PERIOD:

This is a recurring Contest. Dates for each Contest will appear on the Contest web page. Dates may be subject to change. Updates will be reflected on the Contest web page. (each, an “Entry Period”)

3. ELIGIBILITY:

The Contest is open to those Participants that are at least eighteen (18) years old, or are between the ages of 13 and 18 years of age and have your parent’s permission and have a Beatsource account. The Contest is subject to all applicable laws and regulations and is not valid in Brunei, Afghanistan, Cuba, Democratic Republic of Congo, Eritrea, Fiji, Gambia, Indonesia, Iran, Iraq, Kyrgyzstan, Libya, Micronesia, North Korea, Pakistan, Palau, Somalia, Sri Lanka, Sudan, Syria, Russian Federation, and anywhere else such Contests may be void by law.

In addition, the Contest is not open to any employees of The Beatport Group or its subsidiaries, nor any employees of an advertising, promotion, production, or publicity agency doing business with any of the The Beatport Group companies.

Beatsource may prohibit any Participant from participating in or winning the Contest if, in Beatsource's sole discretion, Beatsource determines the Participant is attempting to undermine the legitimate operation of the Contest by (i) cheating, deceiving, or utilizing other unfair practices; (ii) violating the Rules; or (iii) acting in any disruptive manner during, or after, the Contest. By submitting an entry, the Participant accepts the terms of these Rules and agrees to be bound by the decisions of the judges, which will be final.

4. HOW TO ENTER:

You must have an existing Beatsource LINK subscription (may be on a free trial basis at time of entry) and an active Twitter account.

Each Contest will have a “theme,” wherein users will be challenged to create a playlist on the Beatsource platform based on the theme provided. Contest themes will be featured on the Contest page for each Contest.

To enter, you must first create a playlist based on the suggested theme. Once created, complete and submit the entry form located on the Contest web page. Form must be completed within the Entry Period.

All eligible entrants must include one post on Twitter by the Participant, with a link to their playlist using the hashtag #communitycrates. Posting on Twitter is a requirement for winning the Contest.

All Entries must be received by the deadline specified on the Contest web page. Each Entry should be submitted only once. All one Entry allowed per Participant. Use of automatic devices to submit the same material more than once is not permitted. Only electronic Entries submitted via the Contest web page will be accepted.

A "Participant" is any individual who has provided all the requirements as provided above.

5. HOW WILL ENTRIES BE JUDGED

Beatsource's team will review all eligible playlists. One Winner ("Winner") will be selected for each Contest (unless stated otherwise on the Contest web page). Playlists will be judged based on creativity, flow and order of the tracks, adherence to the Contest theme, and generally how much the Participant's playlist stuck out from the rest of the Entries. Judging will not be based on promotional efforts on social media (outside of the requirement to make one Twitter post), traffic to the playlists, or number of plays.

7. PRIZES:

Prizes may vary from Contest to Contest. Please see the Contest web page for Prize information on any given Contest. Retail value is subject to change, but estimated retail value per Prize shall be \$100USD - \$500USD (each, a "Prize"), unless stated otherwise.

All incidental expenses not expressly set forth in the Prize will be Winner's responsibility. No substitution, cash redemption or transfer of the Prize by the Winner is permitted, but Beatsource reserves the right to substitute a prize of equal or greater value for all listed Prize items.

Odds of winning depend on the number of eligible Entries received. Any taxes owed as a result of winning are the sole responsibility of the Winner.

8. NOTIFICATION OF FINALISTS AND WINNER:

Winner will be contacted at the email address provided with the Entry. Any Winner that fails to respond within 72 hours of notification may forfeit the Prize. Beatsource reserves the right to select a substitute Winner due to non-responsiveness.

9. RELEASE:

By participating in the Contest, Participants agree to be bound by the Rules and the decisions of the judges. By participating in the Contest, Participants hereby waive and release, and agree to hold harmless Beatsource, along with Beatsource's parent, subsidiaries, affiliates, distributors, licensors, advertising and promotion agencies and all of its respective officers, directors, employees and representatives and agents (the "Released Parties"), from and against, any and all rights, claims and causes of action whatsoever that they may have, or which may arise, against any of them for any liability for any matter, cause or thing whatsoever, including but not limited to any injury, loss, damage, whether direct, compensatory, incidental or consequential, to person, including death, and/or property, arising in whole or in part, directly or indirectly, from their acceptance, possession, use or misuse of the Prize, or their participation in this Contest, or any Contest or Prize-related activity.

10. OWNERSHIP AND PUBLICITY:

By entering the Contest, Participant grants Beatsource and its parent companies, affiliates, subsidiaries, agents and licensees, a royalty-free, unconditional, irrevocable, and perpetual right, license and consent, without any compensation, consideration or further notification, to use and refer to the Participant, his or her name, likeness, image, distinctive characteristics, city, state, any statements made and prize information, for any purpose, including but not limited to editorial, advertising, trade, commercial, and publicity purposes in any media throughout the world, unless prohibited by law.

11. CONSENT TO EMAIL COMMUNICATION:

By entering the Contest, you grant permission for Beatsource to contact you at the provided e-mail address in reference to this Contest, and, for other general marketing and promotional messages relevant to Beatsource. You may update your email preferences at any time. Your email will not be shared with any party other than those identified in association with the Contest.

12. DISPUTES:

Each Participant agrees that (a) any and all disputes, claims, and causes of action arising out of or in connection with the Contest, or the Prize, shall be resolved individually, without resort to any form of class action, and any judicial proceeding shall take place in a federal or state court in the State of Colorado, (b) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Contest, but in no event attorneys' fees and (c) under no circumstances will Participant be permitted to obtain awards for, and Participant hereby waives all rights to claim

punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Rules, or the rights and obligations of participant and the Beatsource in connection with this Contest shall be governed by, and construed in accordance with the laws of the State of Colorado, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Colorado or any other jurisdiction), that would cause the application of the laws of any jurisdiction other than those of the State of Colorado.

By entering the Contest, Participants acknowledge that they are familiar with the provisions of California Civil Code Section 1542, which provides as follows:

A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS FAVOR AT THE TIME OF EXECUTING THE RELEASE WHICH IF KNOWN BY HIM MUST BE MATERIALLY AFFECTED HIS SETTLEMENT WITH THE DEBTOR.

Accordingly, by entering the Contest, Participants (on their behalf and on behalf of their heirs, executors, administrators, personal representatives, predecessors, successors and assigns of any of the foregoing, and all other persons and entities asserting rights of or acting on behalf of the participant) hereby waive and relinquish any right or benefit which participant or such persons has, have or may have against Beatsource and their respective agencies under Section 1542 of the Civil Code of the State of California, or under any similar statutory or common law of any other jurisdiction to the full extent that any such person may lawfully waive such rights and benefits pertaining to the releases set forth in these Rules and Beatsource's Privacy Policy.
