1. INTRODUCTION

These terms and conditions (these "<u>Terms and Conditions</u>") govern your ("<u>you</u>", "<u>your</u>", or "<u>Entrant</u>") participation in the 'Teddy Swims "Lose Control" DJ Challenge' (the "<u>Contest</u>") operated by Beatsource, LLC ("<u>Beatsource</u>") in collaboration with Warner Records ("<u>Label</u>") (together the "<u>Sponsors</u>" and each a <u>Sponsor</u>"). By entering the Contest, you agree that you have read these terms and agree to be bound by them. Please read carefully, as these terms form a binding legal agreement between you and Sponsors.

2. ENTRY PERIOD:

The Contest consists of certain phases as set forth below:

Submissions for the Contest (each, an "<u>Entry</u>", collectively, the "<u>Entries</u>") will be accepted from March 6, 2024, to March 15, 2024 (the "<u>Entry Period</u>"). Entries received before or after the Entry Period will not be accepted or eligible to win. Sponsors' clock is the official clock of this Contest.
